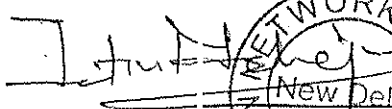
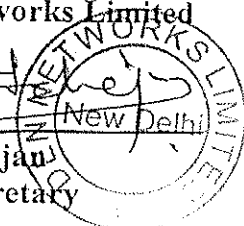

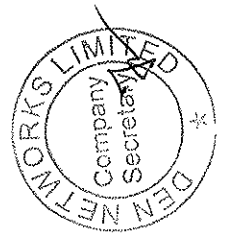

NETWORKS LIMITED held on 14th October, 2016 at 11:00 A.M. at Sri Sathya Sai
International Centre, Pragati Vihar, Institutional Area, Lodhi Road, New Delhi-110003 through
E-voting and voting through Ballot (Physical).
