Textual Information()	<p>During FY 18-19, JFDHPL, JTDHPL & JDDHPL (Acquirers) acquired sole control of the Company pursuant to:(i) Preferential allotment of 28,14,48,000 equity shares representing 58.98%; (ii) Acquisition of 7.04% from Mr. Sameer Manchanda and VEPL (iii) Pre Preferential shareholding of 0.55% by affiliates of Acquirers and (iv) Acquisition of further 12.05% equity shares pursuant to the open offer. The Board of Directors of the Company had approved a scheme of arrangement inter alia for the amalgamation of the Company with Network18 Media & Investments Limited (Network18) and the same was filed with BSE & NSE on February 20 and February 21, 2020, respectively. In terms of the scheme, upon effectiveness of the scheme, the Company would cease to exist and Network18 would continue to be MPS compliant. The scheme (which was returned by the stock exchanges on May 4 / May 5, 2020) has been resubmitted along with representation letter dated July 6, 2020 to SEBI and stock exchanges.</p>
